Personal precautions, protective equipment and emergency procedures: Environmental precautions: Methods and materials for containment and cleaning up:	Use personal protective equipment. Keep people away from and upwind of spill/leak. Ensure adequate ventilation. Entry to non-involved personnel should be controlled around the leakage area by roping off, etc. Prevent product from entering drains. Absorb spilled material in a suitable absorbent (e.g. rag, dry sand, earth, saw-dust). In case of large amount of spillage, contain a spill by bunding.
